The Company

“Oxford Visual Arts Festival Limited” (known as “Artweeks”) was formed in 1981 and is now the largest open studio festival of visual arts in the country. It is directed by a non-executive Board whose members are interested or involved in visual arts and crafts throughout Oxfordshire and organised by a part-time co-ordinator who is appointed by the Board. “Artweeks” refers to the three week, non-selective festival of art which takes place annually, across the county, normally in May.

Membership

The organisation became a company, limited by guarantee in 1999, with all participating artists becoming members of the company. **Only members of the company are entitled to take part in the annual Artweeks festival.** The Company undertakes to enter artists’ exhibition details into the festival guide, to widely publicise the event and supply participants with publicity material. Membership also brings the benefits of regular newsletters, a free guide, the opportunity to meet other local artists and the right to elect new Board members at the Annual General Meeting. Membership is renewable annually on 1st January.
